Introduction

- Every fall, the National Committee for Quality Assurance (NCQA) publishes annual Managed Care Organizations (MCO) quality ratings, based on their combined HEDIS® and CAHPS® scores and NCQA Accreditation status.
- Plans are rated on a o-5 scale, with each entity given a rating rounded to the nearest half number (e.g., 3.0, 3.5, etc.).
- This edition of the 5 Slide Series presents some of our tabulations of the Medicaid quality ratings for NCQA's 2022-2023 Rating Year.
- Published overall ratings have strong visible importance in the eyes of consumers, regulators and health plans. However, it should be noted that the rounding of the ratings to the nearest half or full star can mask actual performance (e.g., 3.75 through 4.24 will round to 4.0).

Distribution of NCQA Ratings Across the Medicaid MCO Industry

- In the 2022-2023 Rating Year, most health plans (95%) were rated 3.0 stars and above, 28% were rated 4 stars and above, and 27.5% were rated 3 stars and below.
- The national average rating was 3.455, over the two most recent years.

The five MCOs in Massachusetts achieved the highest average rating of 4.30 stars, whereas Arizona's two MCOs received the lowest average rating of 2.25 stars.
