Medicaid Unwinding Overview



Introduction: This first edition of our Medicaid Unwinding 5 Slide Series provides an overview of Medicaid eligibility and enrollment trends during and after the COVID-19 public health emergency (PHE).




Background: To protect health coverage for millions of Americans during the COVID-19 PHE, Congress enacted a continuous coverage provision in March of 2020, pausing annual Medicaid redeterminations. The following slide presents a timeline of key events leading to the Medicaid continuous enrollment requirement and the subsequent Medicaid unwinding. "Medicaid Unwinding" refers to the resumption of annual Medicaid eligibility reviews by states after the continuous coverage requirement ended.



Upcoming: Future editions will explore the factors contributing to variations in Medicaid enrollment trends across states, including differences in renewal practices. We will also compare state Medicaid enrollment changes with Medicaid prescription usage trends, exploring the degree to which those losing coverage tended to be individuals with low/no prescription drug use.

Medicaid Unwinding Renewal Timeline: 50 States + D.C.

States were allowed flexibility in carrying out the "unwinding" process, though terminations of Medicaid coverage could not take effect until April 1, 2023. The first disenrollment typically occurs 60 days after the renewal process has been initiated. Since the continuation of Medicaid redeterminations, the Centers for Medicare and Medicaid Services (CMS) has approved additional flexibilities, mitigation strategies, and alternative approaches that have impacted states' initial timelines.


The following tables outline the Medicaid Unwinding timelines followed by all 50 states and D.C. This includes the start month for each state's redetermination process and the anticipated completion dates.

National Medicaid Enrollment Trends (cont.)

Pre-Public Health Emergency

- Prior to the PHE, Medicaid enrollment numbers remained fairly steady in recent years.
- Medicaid enrollment **slightly declined by 0.8%**, from approximately **72 million** in January 2019 to **71.4 million** in January 2020.

Medicaid Continuous Coverage Period

- During the COVID-19 PHE, the Maintenance of Effort (MOE) requirement prevented states from disenrolling Medicaid beneficiaries, even if they became ineligible under pre-PHE guidelines. Coupled with the spike in unemployment, which made many individuals newly eligible, Medicaid enrollment steadily increased during this period.
- Enrollment numbers rose by 31.3%, from approximately 71.7 million in March 2020 to a peak of 94.1 million in March 2023.

Medicaid Unwinding (Redeterminations)

- Beginning in May 2023, enrollment numbers started to decline as states resumed regular eligibility reviews and disenrollment processes.
- Medicaid enrollment dropped to **79.4 million** by August 2024, representing a **15.6% decrease** from March 2023.

Medicaid Enrollment Remains Higher in 44 States -- Even After the "Unwinding" -- Relative to Pre-COVID Levels

States with Largest Growth from Jan 2020 – Aug 2024:

- The four states with the largest enrollment growth from pre-COVID levels have implemented Medicaid Expansion in recent years.
 - North Carolina (+55%) → Medicaid Expansion implemented December 2023
 - Missouri (+50%) → Medicaid expansion implemented in August 2020, with coverage beginning in July 2021.
 - Nebraska (+39%) \rightarrow Medicaid Expansion implemented in October 2020
 - Oklahoma (+35%) \rightarrow Medicaid Expansion implemented in July 2021

States with the Largest Enrollment Decline from Jan 2020 – Aug 2024:

• Montana (-14%), Colorado (-8%), and Arkansas (-5%) saw the most significant decreases in Medicaid enrollment.

National Growth in Medicaid Enrollment (Jan 2020 – Aug 2024):

- The overall national growth (+11%) masks significant state-level variation, highlighting the role of state policies and economic conditions in Medicaid enrollment trends.
- From January 2020 to August 2024, national Medicaid enrollment grew by 8,000,699
 persons, with 1,804,863 of this net growth (22.6%) occurring in the seven states that
 implemented Medicaid expansion during this timeframe (ID, MO, NC, NE, OK, SD, UT).

Medicaid Enrollment Changes by State During the Redetermination Period

Overall, Medicaid enrollment in the United States decreased by 15.6% from March 2023 to August 2024.


Largest Decline in Enrollment:

 Montana experienced the largest percentage enrollment drop-off at -32.7%, followed by Idaho (-31.7%), Colorado (-31.2%) and Utah (-30.8%).

Smaller Decreases and Minimal Changes:


- **Maine** had the smallest percent decline (-2.0%).
- Alaska (-5.6%), South Dakota (-5.8%) and California (-6.0%) had the next-smallest declines. South Dakota's modest decrease is due their implementing Medicaid Expansion in July 2023.
- Increased Enrollment: North Carolina is the lone state experiencing increased Medicaid enrollment during this timeframe (+18.4%). This is attributable to North Carolina newly implementing Medicaid expansion beginning in December 2023.

Regional Analysis: Medicaid Enrollment Changes During the Redetermination Period (March 2023-August 2024)

Excluding states that adopted Medicaid Expansion after March 2023 (i.e., North Carolina and South Dakota), the nation experienced a **16.5% drop** in enrollment during the Redetermination Period (as of August 2024).

- <u>Midwest</u>: States in the Midwest experienced a slightly larger enrollment decline than the national trend, with a **17.2%** drop (excluding SD which expanded Medicaid in July 2023).
- <u>Northeast</u>: The Northeast experienced a relatively smaller decline in enrollment, with an overall decrease of **14.6%**.
- <u>South:</u> Southern states exhibited the largest reduction in Medicaid enrollment, with an overall decrease of **21.6%** (excluding NC which expanded Medicaid in December 2023).
- <u>West:</u> States in the west experienced the smallest reduction in enrollment, with an overall decrease of -11.4%.
